- Top subsector stock performers in Q1 of 2017 included For-Profit Educational and Vocational Institutions and Digital Educational Content & Services, up 12.9% and 9.4%, respectively
- On average, the stock price indices for the subsectors outperformed the S&P 500 Index by 5.5% during Q1 2017, again led by strong performance in the For-Profit Education and Vocational Institutions subsector
- On average, EBITDA multiples for the subsectors were down by 0.1x over the prior quarter and up 1.7x on a year over year basis






