# LI Facilities Services ("FS") Index decreased (5.7%) this quarter

## **About the LI Facilities Services Index**

The LI Facilities Services Index is a market cap weighted composite stock index similar to the S&P 500 Index. The index is prepared by first selecting a base period, in this case, Q2 2016, and totaling the market caps of the companies in this period. This period and the total market cap is set to a base index at 100%. Next, the current period's total market cap is calculated, divided

by the base period's total market cap and then multiplied by the base index (100%). The result is the index value used for plotting the Relative Stock Index Performance graph below. A full list of the companies included in the LI Facilities Services Index can be found on page 3. Figures shown below are historically updated to reflect the updated LI Facilities Services Index.





3/20/2018: Aramark, the U.S.-based food, facilities and uniform services provider, is looking to make acquisitions in Belgium. Aramark's CEO stated that the company plans to make one or two acquisitions in the coming months

3/12/2018: Johnson Controls, the U.S.based industrial solutions conglomerate, is exploring strategic options for its Power Solutions business. Johnson Control's CEO stated that the initiative, "reflects our strategic priority to strengthen and invest in our global market-leading positions in HVAC, fire and security solutions"

2/09/2018: FirstService, the Canada-based facilities services provider, plans to pursue bolton acquisitions. According to The Globe and Mail, the company's management provided a 2018 outlook that called for opportunistic deals and mid-single-digit organic revenue expansion

1/23/2018: US Security Associates, the U.S.-based security services provider, is preparing to explore a sale. The company generates north of \$100 million in adjusted **EBITDA**
