


- (6/27/13) Burlington Holdings files with the SEC for a \$175m IPO
- KKR suggests a merger between Saks and Neiman Marcus, but Neiman Marcus ultimately declines; Hudson's Bay announces an interest in Saks
- Coach is considering acquiring an accessories brand
- Wolverine Worldwide is focused on reducing debt following the acquisition of the Performance + Lifestyle Group brands from Collective Brands; would consider a divestiture (total debt as of 6/15/13 is \$1.2bn)
- Aerosoles owner, Grumman Hill, is seeking a buyer or strategic partner to work with Aerosoles' current management team
- Fifth and Pacific is collecting bids for its Juicy Couture and Lucky brands; Jos. A. Bank Clothiers, which is actively seeking acquisitions, submitted a bid for Lucky; Juicy Couture founders are seeking to repurchase brand

(4/22/2013) Fifth and Pacific amends and restates credit facility; acquisitions are permitted, subject to certain payment conditions
