


### Market Intelligence

- 9/25/13: Apparel Holding Corp., a New York -based apparel company with a collection of fashion brands, filed with the U.S. SEC for an IPO worth \$200 million. The company plans to use proceeds to fund new store openings, for general corporate purposes and to repay debt
- After months of pursuing Men's Wearhouse, Jos A Bank recently terminated its nonbinding proposal of \$48 per share, which was submitted in early October. Eminence
  Capital, the largest shareholder of Men's Wearhouse, has expressed support for the merger and continues to push for it
- Jones Group continues moving forward in a sale process, with the possibility of a split of its footwear and apparel businesses.
  Recently, G-III Apparel, which was believed to be acquiring the apparel portion of the business, exited the process. Sycamore
  Partners reportedly has been negotiating for the footwear business
- Fifth and Pacific continues to pursue a sale of Lucky Brand jeans following unsuccessful negotiations with Advent International
- BRZZ Gear, which recently acquired Granite Gear, a backpack and luggage company, is actively seeking complementary buys, likely in the outdoor category
- Maria Oiticica, a private, Brazilian jewelry company, expressed an interest in taking on a 30% partner to support internationalization plans. It plans to open two new locations in New York City and Paris
