
Market Intelligence

- VF Corporation Chairman Eric Wiseman told Women's Wear Daily that the company aimed to expand its outdoor and active sportswear business. Additionally, management views larger acquisitions as more appropriate for a company of its size and it has both the confidence and financial capability to pursue such a strategy.
- Urban Outfitters will continue to engage in talks regarding potential acquisitions and hopes to announce a deal this year, according to CEO Richard Hayne.
- Perry Ellis International Inc. is probably being readied for sale, The Deal reported, citing two sources familiar with the situation. A source mentioned VF Corp. and G-III Apparel Group Ltd. as possible buyers.
- Crocs to explore strategic alternatives for non-core brands according to management.


