Index Performance


Lincoln's Distribution Index recorded a loss of 0.6% in Q3 2016 vs. Q2 2016; Communications, **Electronics** and Electrical (+20.4%), Technology (+10.3%), Aerospace and Defense (+9.5%), Industrial (+3.9%) and Building Products (+1.6%) outpaced the index. while Automotive and Truck (-1.2%), **Consumer Products** (-6.9%) and Healthcare (-7.6%) lagged behind the index




