#### **Index Performance**


Lincoln's Distribution Index recorded a loss of 0.3% in Q1 2017 vs. Q4 2016; Healthcare (+8.8%), Building Products (+4.9%), Industrial (+2.7%), Communications, **Electronics and Electrical** (+1.8%) and Technology (-0.2%) outpaced the index, while Consumer Products (-1.7%), Automotive and Truck (-6.2%) and Aerospace and Defense (-6.6%) lagged behind the index






# **Distribution Index – LTM Relative Stock Price Performance**

3/8/2017: Genuine Parts Company, the Georgia-based distributor of Atlanta. automotive and industrial replacement parts, office products and electrical/electronic materials, continues to look for further acquisitions in 2017 after the company acquired 19 businesses with revenues totaling \$600 million in 2016

3/1/2017: Kaman Corporation, the Bloomfield, Connecticut-based aerospace manufacturer and industrial parts distributor, is turning its attention back to M&A after spending 2016 integrating two acquisitions which it completed in late 2015

2/21/2017: MRC Global, the Houston, Texas-based distributor of industrial pipes, valves, fittings and related products, maintains an active list of potential targets and considers M&A to be a key part of its expansion strategy

2/16/2017: US Foods, the Rosemont, Illinois-based foodservice distributor which announced two acquisitions during Q1 2017, continues to target acquisitions of broadline distributors with a high mix of independent restaurants and distributors with capabilities in produce and meat
