LI Facilities Services ("FS") Index increased 2.6% this quarter


About the LI Facilities Services Index

The LI Facilities Services Index is a market cap weighted composite stock index similar to the S&P 500 Index. The index is prepared by first selecting a base period, in this case, Q3 2016, and totaling the market caps of the companies in this period. This period and the total market cap is set to a base index at 100%. Next, the current period's total market cap is calculated, divided

by the base period's total market cap and then multiplied by the base index (100%). The result is the index value used for plotting the Relative Stock Index Performance graph below. A full list of the companies included in the LI Facilities Services Index can be found on page 3. Figures shown below are historically updated to reflect the updated LI Facilities Services Index.



Heard on the Street

6/28/2018: Brightview, the U.S.-based landscaping services provider, has sold 21.3 million shares for \$22 a share in its public offering on the NYSE, raising \$468.6 million in the process.

6/28/2018: Restaurant Technologies, the U.S.-based cooking oil management company, is preparing for a sale. This expected sale comes simultaneous to the sale of a similar asset, **Mahoney Environmental**, a cooking oil recycling company.

6/25/2018: Fleetwash, the facility cleaning and vehicle washing services provider, is in the beginning stages of a sale process. Sponsor, **DFW Capital Partners**, is marketing the Company on approximately \$20 million in LTM EBITDA. Prospective buyers are expected to value the business at a range of 7x-9x EBITDA. **6/20/2018: Compass Group,** the U.K.based food and support services provider, has collected first-round bids for the laundry services business of its U.S. subsidiary, Crothall Healthcare. This unit of the business generates approximately \$30 million in EBITDA. The transaction is part of a disciplined divestiture strategy to strengthen Compass' core business.

6/1/2018: CSC ServiceWorks, the U.S.based commercial laundry company, is preparing to explore a sale in response to inbound interest. The company generates more than \$350 million in EBITDA.

4/24/2018: PureStar Linen Group, the U.S.-based outsourced laundry and dry cleaning services provider for the hotel and hospitality industry, is exploring a sale.
