

Selected M&A Trends and Observations

- Behavioral M&A deal volume was up 50% in the first nine months of 2015 versus the prior comparable period in 2014⁽¹⁾
- Private equity groups have been particularly active in acquiring a significant number of platform companies in this industry in 2014 and 2015, while certain private equity groups have also started to exit, often trading their investment to another PE firm. Examples of new private equity entrants include: Flexpoint Ford, Kohlberg & Co., Levine Leichtman, Pharos Capital, Shore Capital, Summit Partners, Webster Capital, etc.
- As a result, we now count over 35-40 behavioral health platform companies that have received professional financial backing. Many interested private equity players are looking at the entire breadth of the behavioral health services spectrum (pediatric to geriatric, inpatient to outpatient, mental health to methadone, etc.), but are also interested in related segments (e.g., contract behavioral health, behavioral health pharmacy, information systems and services, etc.)
- Among the largest providers in the space, the publicly traded providers also remain active on the acquisition path, including Acadia Healthcare, Universal Health Services and American Addiction.
- Behavioral health is also rapidly evolving around the world. We are observing substantial M&A and investment activity in several countries across the world, including private equity investments
