
## Lincoln International Home Health & Community-Based **Healthcare Indices**

### Last 7 Quarters Relative Stock Price Performance





## Market Observations by Segment

HHBC: The Home Health & Community Based Care services segment (excluding specialized pharmacy and supplies) is heading toward yet another great M&A year. Over the most recent few months, numerous skilled home health, unskilled home care, hospice and pediatric home health deals have added nicely to a burgeoning deal count. Of note: new private equity entrants (e.g., Geneva Glen Capital acquiring Southeastern Home Health); Hospice Compassus and Curo Health both active in the hospice arena; Epic (most active) and PSA, buoyed by capital continuing to spend money across the pediatric home & community spectrum; among participants, LHC Group appears the most active buyer; some ongoing activity in adult day health since last year's bellwether acquisition of Senior Care/Active Day by Audax Group (with Lincoln serving as sell-side financial advisor); a regular flow of Medicaid and unskilled home care deals; and a number of home care franchisor deals remain of interest.

PHAR: Steady number of transactions in this segment, particularly over the past 3-5 months. The most active sub-segment specialty pharmacy. continues to be Diplomat Pharmacy remains an active acquiror, most recently purchasing TNH Pharmacy (for which Lincoln served as sellside financial advisor). Kroger's Axium pharmacy platform added in a major way by acquiring Altamont Capital's ModernHEALTH. Other retail pharmacy companies, like Meijer and Long's Drug, are also busy in the M&A market. In home infusion, Bioscrip purchased KRG Capital's Home Solutions.

HMS: The direct-to-patient home medical supplies provider space has seen meaningful uptick in transactional activity over the past Of note: Domtar's several months. announced, pending acquisition of Home Delivery Incontinent (with Lincoln serving as sell-side financial advisor). Other buyers making inroads into direct-to-consumer supplies channels include C.R. Bard (acquiring Liberator in late 2015). Pediatric home health nursing provider Epic Health Services has also diversified its service offering and is trying to leverage its patient base by offering direct-topatient supplies, with its 2015 Option 1 acquisition being the launch point for this strategic initiatives.

International Transactions: There continues to be consistent in home healthcare deals in non-United States markets, particularly in European countries, where several private equity backed players are active consolidators. In addition, home infusion provider deals, again predominantly in Europe, is an active M&A arena. Among the most active countries for HHBC and PHAR are the United Kingdom, Germany, and France. Finally, private equity buyers in Europe remain actively interested and investment-oriented in the home infusion market.
