- Several companies are exploring strategic alternatives, including Anchor Glass (KPS Capital Partners), Consolidated Container (Bain Capital), Letica, Linpac and Stora Enso (HLSE:STERV)
- 9/2016 **Greiner Packaging** is planning to use acquisitions to expand its presence outside of Europe in emerging markets such as China, India, Brazil and Russia
- 9/2016 Supremex (TSX:SXP) is actively seeking M&A opportunities in both the U.S. and Canada to grow its packaging segment
- 9/2016 **Huhtamaki** (HLSE:HUH1V) has altered its acquisition strategy to focus on smaller targets in an effort to mititage risk
- 8/2016 Sealed Air (NYSE:SEE) is currently seeking acquisition targets in India; ideal targets are niche automation

- 7/2016 Universal Forest Products (NASDAQ:UFPI) is seeking acquisitions and is building out a viable pipeline of targets


